Ocoee, FL – The Florida Department of Transportation (FDOT), Florida's Turnpike Enterprise (FTE) will hold a Public Information Meeting for Florida's Turnpike (SR 91) Widening from Jupiter (Indiantown Road/SR 706) to Ft. Pierce (Okeechobee Road/SR 70) Project Development and Environment (PD&E) Study in Palm Beach, Martin and St. Lucie Counties, Florida (Financial Project Identification (FPID) Number: 423374-1; Efficient Transportation Decision Making (ETDM) Number: 14295).
