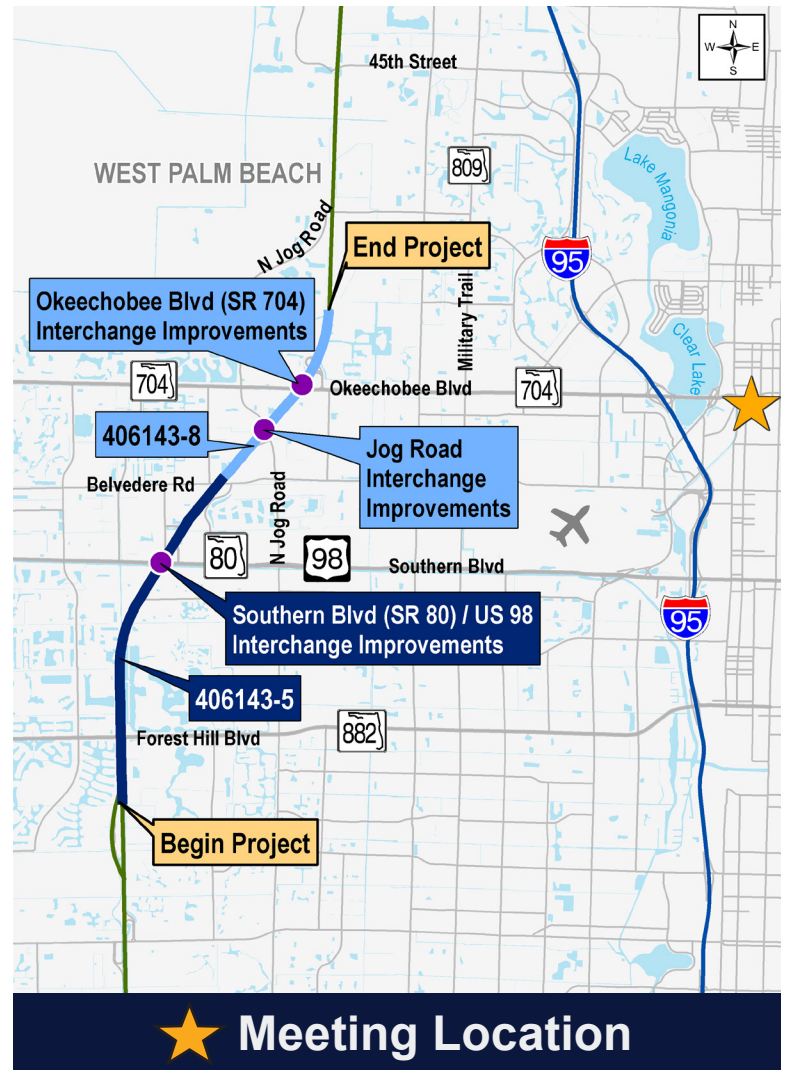
## Overview

The Florida Department of Transportation (FDOT), Florida's Turnpike Enterprise is planning to widen the Florida's Turnpike Mainline (SR 91) from the West Palm Beach Service Plaza to north of Okeechobee Boulevard (SR 704) in Palm Beach County. The projects cover approximately seven (7) miles of the Turnpike Mainline (SR 91).

The projects will help enhance safety, increase capacity, alleviate current congestion, and improve operational issues along this section of the Turnpike. The proposed improvements include widening this segment to increase the number of lanes from four (4) to eight (8) lanes, as well as improvements at three (3) existing interchanges: Southern Boulevard (SR 80), Jog Road, and Okeechobee Boulevard (SR 704). The projects will also include milling and resurfacing, bridge improvements/replacements, and stormwater drainage improvements. Noise walls will be constructed throughout the project limits in qualifying areas.

## Key Improvements

- Widening from four (4) to eight (8) lanes
- Improvements at Southern Boulevard (SR 80), Jog Road, and Okeechobee Boulevard (SR 704) interchanges
- Bridge improvements/replacements
- Drainage improvements
- Construction of noise walls where reasonable and feasible
