PROJECT OVERVIEW

Located in southern Miami-Dade County near the City of Homestead, this project will provide necessary improvements to ensure smooth connections between Florida's Turnpike (SR 821) and important local roads. The project will address traffic capacity needs along Florida's Turnpike and will extend the life of the existing roadways and ramps in the project area through repaving.

KEY IMPROVEMENTS

- Widening from 4 lanes to 6 lanes with 1 thru lane to increase capacity
- Repaving of the roadway
- Noise walls in qualifying areas
- New northbound entrance ramp from Tallahassee Road
- Biscayne Drive and Tallahassee Road interchange improvements
- Signal improvements
- Signing and pavement marking improvements
