



# Florida's Turnpike/SR 91 Transportation Systems Management & Operations Project to Add Auxiliary Lanes from Turnpike Extension/SR 821 to Griffin Road/SR 818

## Project Description

Florida's Turnpike Enterprise is implementing a Transportation System Management and Operations (TSM&O) initiative adding a lane in each direction of Florida's Turnpike/State Road (SR) 91 between the Turnpike Extension/SR 821 and Griffin Road/SR 818, in Broward County.

Benefits of this project include:

- Increasing roadway capacity, reducing congestion and improving travel times by adding a lane in each direction of the Turnpike Mainline
- Enhancing local road safety at Hollywood Boulevard/SR 820 and SW 63 Terrace by closing the median to reduce vehicle conflicts and accidents, and at Hollywood Boulevard and S. 62 Avenue by eliminating the eastbound and westbound turn lanes
- Improving local road traffic flow by adding a second left turn lane from southbound N. 64 Avenue to eastbound Hollywood Boulevard and an additional right turn lane at the northbound and southbound exit ramps
- Reducing noise levels by constructing sound walls along qualifying residential areas adjacent to Florida's Turnpike
- Strengthening roadside safety by installing new lighting, signage, and pavement markings

## Construction and Traffic Impacts

Construction will take place during both daytime and nighttime hours. Nearby residents and businesses may experience periodic construction noise, vibration, and dust. The Enterprise takes steps to reduce construction impacts and efforts will be made to limit traffic and noise disruptions.

Lane closures will generally take place during off peak hours to minimize traffic congestion and delays for most drivers. Closures will be announced in advance in the South Florida and Treasure Coast Weekly Lane Closures and Work Zone Advisory.

### Schedule and Funding

#### Construction Schedule

Work is anticipated to be completed by late 2029.

#### Cost and Funding

The project cost is approximately \$ 230 million.

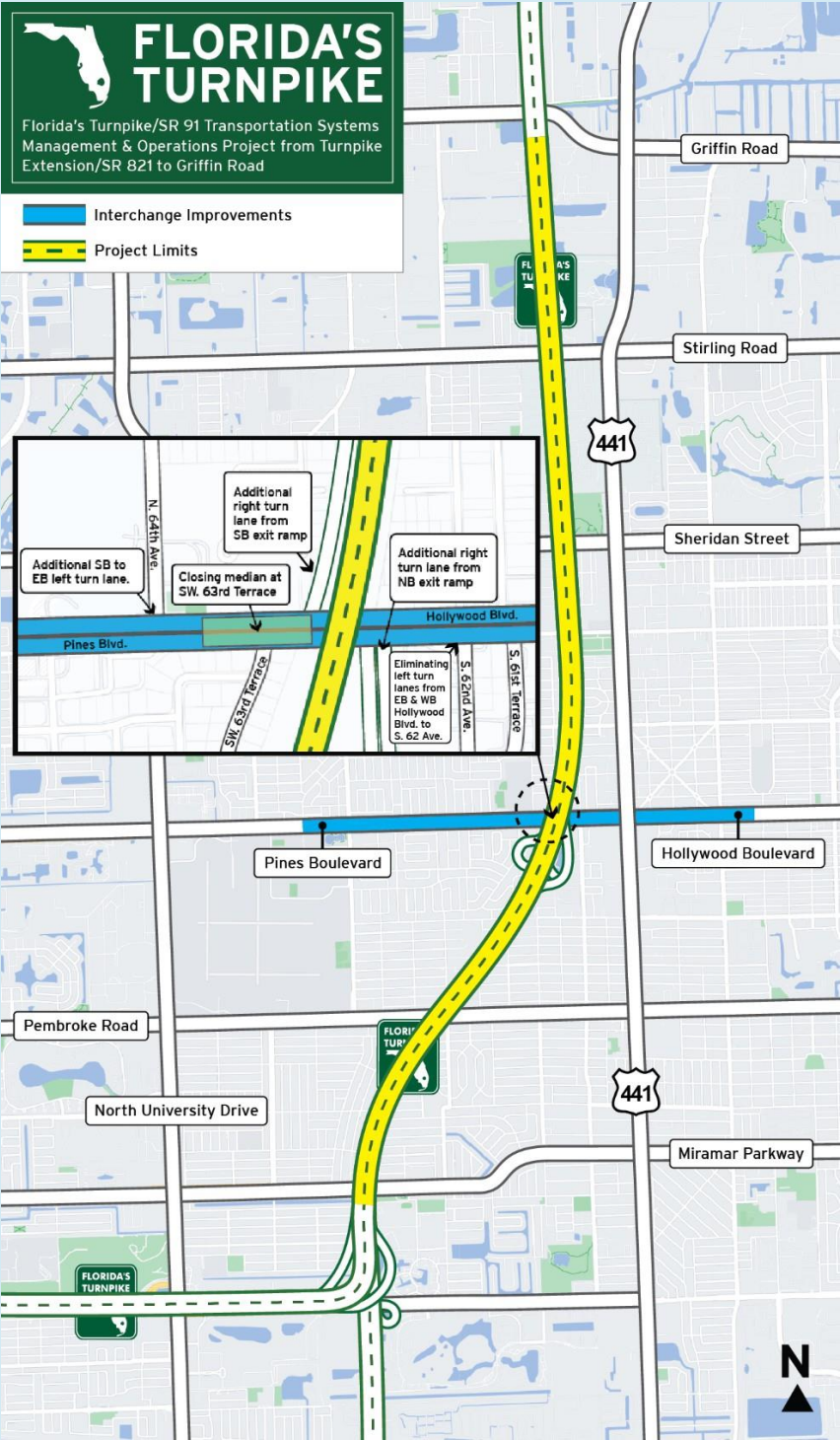
